1. INTRODUCTION:

Konkan Railway Corporation Limited (KRCL) invites **ONLINE** applications for various categories posts. The following candidates are eligible to apply:

- (i) **Land loser candidates:** The candidates whose land has been acquired for construction of the Konkan Railway Line between Roha in the State of Maharashtra and Thokur in the State of Karnataka, irrespective of the percentage of land lost.
- (ii) Such persons himself/herself and /or his family comprising of his/her spouse (wife/husband), son, daughter, grandson and grand daughter only are eligible for employment under landloser quota in KRCL, subject to fulfilment of the prescribed eligibility criteria and other conditions of Recruitment. The Policy is available in KRCL website i.e., www.konkanrailway.com.
- (iii) **Other than land loser candidates:** The candidates who are domicile of Maharashtra, Goa, or Karnataka and have valid employment exchange cards registered with the Employment Exchanges along the Konkan Railway route within the jurisdiction of Konkan Railway Corporation Ltd. (Raigad, Sindhudurg, and Ratnagiri Districts of Maharashtra, Goa State and Uttara Kannada, Udupi and Dakshina Kannada/South Kannada Districts of Karnataka)
- (iv) **Other than land loser candidates:** The candidates who are domicile of the States of Maharashtra, Goa State, and Karnataka.
- (v) **KRCL employees:** KRCL employees who have completed at least three years of regular service in KRCL.

Panels will be prepared on the basis of preference for recruitment, i.e., for land loser candidates, Employment Exchange registered candidates along with KR route and other than land loser candidates who are domicile of the States of Maharashtra, Goa State and Karnataka.

The panels will be prepared on the basis of preference for recruitment in the following order:

- a) Land loser candidates,
- b) The candidates registered in the Employment Exchanges along the KR route,
- c) The candidates domiciled in Maharashtra, Goa, or Karnataka States besides the ones mentioned in a) and b) above and eligible KRCL employees.

To avail above preferences, the candidates have to declare their status (Land loser / Employment Exchange / Domicile) at the time of application itself. Land-loser candidates will be given priority for appointment. The second and third panels will be operated only after exhausting the panel of eligible land losers, depending upon the shortfall in the vacancies notified.

Panels will be prepared for land loser candidates, the candidates registered in the Employment Exchanges along the KR route, and non-land loser candidates domiciled in Maharashtra, Goa, Karnataka, plus KRCL employees. Preference shall be given only in

Recruitment and seniority of appointed candidates will be governed as per Indian Railway Seniority Rules.

Note:

(a) Recruitment in Erstwhile Group-D posts is limited to Land loser candidates only. Accordingly, the vacancies in Track Maintainer category shall be filled through eligible Land loser candidates only.

(b) Serving KRCL employees are also eligible to apply subject to fulfilling the notification's terms and conditions, i.e., age, educational qualification, reservation, etc. After completing the online application, such employees should invariably inform their immediate supervisor/controlling officer about their application. The selection of serving employees against this notification shall be subject to D&AR and Vigilance clearance.

This notification provides for Vertical Reservation for Scheduled Caste (SC), Scheduled Tribe (ST), Other Backward Class-Non-Creamy Layer (OBC-NCL), Economically Weaker Section (EWS), and Horizontal Reservation for Ex-Servicemen (Ex. SM) and Persons with Benchmark Disabilities (PwBDs).

NOTE: EBC & EWS are different categories. EBC candidates are not entitled to any job reservation.

Any unfilled vacancies of Ex-Servicemen (Ex. SM) and Economically Weaker Section (EWS) shall not be carried forward. The notification provides for horizontal reservation for Ex-Servicemen (Ex. SM) and Persons with Benchmark Disabilities (PwBD), irrespective of their community, wherever applicable and admissible.

5. ELIGIBILITY CRITERIA:

5.1 AGE LIMIT - 18 to 36 years for the **Group 'C' posts**.

The lower age limit is standard for all the notified posts. The age shall be reckoned as on 01/08/2026.

The relaxation in the upper age limit for the following categories/communities in the table below is applicable, subject to the submission of requisite certificates in the prescribed format at the time of DV for the **Group 'C' posts**.

- The candidates who wish to be considered against reserved vacancies or seek age relaxation must submit the requisite/relevant certificate in original from the Competent Authority in the prescribed format at the time of DV. Otherwise, their claim for SC/ST/OBC-NCL/ExSM/PwBD/EWS status will not be considered, and their candidature/applications will be considered under the General (UR) category if otherwise eligible. The certificates in the prescribed format should be annexed. Certificates submitted in any format other than those prescribed in this notification will not be accepted. **No additional time period shall be permitted.**
- Service personnel likely to be discharged from military service on or before 31/07/2027 are eligible to apply against this employment notice as Ex-Servicemen.
- The candidates eligible for age relaxation on more than one ground will benefit from the category with the maximum relaxation and will **not get the cumulative benefit.**
- SC, ST & OBC (NCL) candidates applying against UR vacancies will not get any age relaxation.
- PwBDs candidates applying against UR vacancies will be allowed age relaxation applicable only for PwBD (UR), subject to suitability conditions.

6. LAND LOSER CANDIDATES:

- Land loser candidates:** The candidates whose land has been acquired for construction of the Konkan Railway Line between Roha in the State of Maharashtra and Thokur in the State of Karnataka irrespective of the percentage of land lost.
- Such persons himself/herself and/or his family comprising of his/her spouse (wife/husband), son, daughter, grandson and grand daughter only are eligible for employment under landloser quota in KRCL, subject to fulfilment of the prescribed eligibility criteria and other conditions of Recruitment. The Policy is available in KRCL website i.e., www.konkanrailway.com.

The candidates should read the Recruitment Policy for Non-Executives (Group 'C' & Erstwhile Group 'D') through open market recruitment in KRCL dated 21/07/2026 which is available on KRCL website www.konkanrailway.com → Departments → Personnel → Recruitment Policy.

Land loser candidates also can apply as the candidates registered in the Employment Exchanges along the KR route or as the candidates domiciled in Maharashtra, Goa, or Karnataka. In such cases, they will not be eligible for the land loser benefits.

6.1 PREFERENCE IN RECRUITMENT:

The candidates securing the minimum qualifying marks prescribed for the posts shall be given preference in recruitment in the following order:

- 1. Land loser candidates:** Eligible land loser candidates will be given first preference for recruitment. The land loser candidates have been defined in terms of this office letter no.CO/PERS/LL/RECT.POLICY/2026(3952) dated 21/07/2026 (also mentioned in para 6 of this notification).
- 2. The candidates registered in Employment Exchanges along KR route:** Second preference for recruitment will be given to other than land losers who are domicile of Maharashtra, Goa, Karnataka and are registered with the Employment Exchange along Konkan Railway route within the jurisdiction of Konkan Railway Corporation Ltd. (Raigad, Sindhudurg and Ratnagiri Districts of Maharashtra, Goa State, Uttara Kannada, Udupi and Dakshina Kannada/South Kannada Districts of Karnataka).
- 3. Domicile of Maharashtra, Goa, Karnataka, and KRCL employees:** Third preference for recruitment will be given to non-land losers domiciled in Maharashtra, Goa, Karnataka, and KRCL employees.

Note:

a) Panels will be prepared for land loser candidates, the candidates registered in the Employment Exchanges along the KR route, and non-land land loser candidates domiciled in Maharashtra, Goa, Karnataka and KRCL employees. Preference shall be given only in Recruitment and seniority of appointed candidates will be governed as per Indian Railway Seniority Rules.

b) To avail of the above preferences, the candidate must declare his/her status at the time of submission of application.

7. VERTICAL RESERVATION:

7.1 This notification provides for vertical reservation for Economically Weaker Sections (EWS), Scheduled Caste (SC), Scheduled Tribe (ST), and Other Backward Class (Non-Creamy Layer) (OBC-NCL), wherever applicable and admissible under extant rules. Only those communities recognized by the Government of India as SC, ST and OBC (Non-Creamy Layer) are eligible for reservation.

NOTE: EBC & EWS are different categories. EBC candidates are not entitled to any job reservation.

7.2 All the candidates, irrespective of community, will be considered against general, i.e., unreserved (UR) vacancies (subject to fulfilment of eligibility conditions required for UR). However, vacancies reserved for specific groups (viz., SC, ST, OBC(NCL) & EWS) will be filled only by the candidates from that community/category.

7.3 Hence, EWS, SC, ST, and OBC-NCL candidates who fulfil the requisite educational and technical qualifications can also apply against UR vacancies, for which they will have to compete as general (unreserved) candidates without any relaxation/concession in age, educational qualification, marks, etc. at any stage of examination. In any case, the candidates are advised to indicate their actual community in the application.

7.4 For availing reservation, EWS, SC, ST & OBC-NCL candidates should furnish the necessary certificates (in original) during DV. The certificates should be issued by competent authorities as per the formats given at Annexure-III (for SC & ST candidates), Annexure-IV (for OBC-NCL candidates) and Annexure-VIII (for EWS candidates).

7.5 The caste certificate for OBC-NCL candidates should specifically mention that "This is also to certify that he/she does NOT belong to the persons/sections (Creamy Layer) mentioned in Column 3 of the Schedule to the Government of India, Department of Personnel & Training OM No. 36012/22/93-Estt.(SCT) dated 08/09/93 and modified vide GOI DOPT OM No. 36033/1/2013-Estt.(Res.) dated 13/09/2017* (*further revision if any, received till the closing date of submission of applications against this notification).

7.6 A person seeking an appointment based on the reservation to OBCs must ensure that he possesses the caste/community certificate and does not fall into a creamy layer on the closing date for application submission. During DV, such candidates should produce their original OBC-NCL certificate (in prescribed format), valid as on the closing date for submission of application, and also a self-declaration (in the format given in Annexure-V) stating that they "do not belong to creamy layer". Otherwise, their claim for reservation (as OBC-NCL) will not be accepted, and instead, they shall be treated as UR candidates only, subject to fulfilment of all other eligibility conditions.

7.7 IMPORTANT: Community/category status as of the closing date for submission of applications against this notification shall only be considered for reservation and related benefits as per eligibility. Any change in this status thereafter shall not be entertained.

7.8 EWS (Economically Weaker Section) Reservation:

The candidates not covered under the scheme of reservation for SC/ST/OBC-NCL and whose family gross annual income is below Rs. 8 Lakh (Rupees Eight Lakh) are to be identified as EWS for the benefit of reservation for EWS. The income shall also include income from all sources, i.e., salary, agriculture, business, profession, etc., for the financial year prior to the year of application. Also, the candidates whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of family income:

7.8.1: 5 acres of agricultural land and above;

7.8.2: Residential flat of 1000 sq. ft. and above;

7.8.3: Residential plot of 100 sq. yards and above in notified municipalities;

7.8.4: Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

The property held by a family in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status. The term 'Family' for this purpose will include the person who seeks the benefit of reservation, their parents and siblings below the age of 18, and their spouse and children below the age of 18. The benefit of reservation under EWS can be availed upon producing an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in the prescribed format as given in Annexure-VIII shall only be accepted as the candidate's claim as belonging to EWS:

- A) District Magistrate / Additional District Magistrate / Collector / Deputy Commissioner / Additional Deputy Commissioner / 1st Class Stipendiary Magistrate / Sub-Divisional Magistrate / Taluka Magistrate / Executive Magistrate/ Additional Assistant Commissioner;
- B) Chief Presidency Magistrate/Additional Chief Presidency Magistrate / Presidency Magistrate;
- C) Revenue Officer not below the rank of Tehsildar;
- D) Sub-Divisional Officer of the area where the candidate and/or his family normally resides.

The candidates applying against the vacancies reserved for EWS must possess an Income and Asset Certificate as of the closing date of submission of applications against this notification. Accordingly, they have to fill out the certificate number, date of issue of the certificate, issuing authority, district, and state of issue in the ONLINE application. Further, these candidates must also produce valid Income and Asset Certificate during document verification. In case of non-compliance to these stipulations, their claim for reserved status under EWS will not be entertained. The candidature/application of such candidates, if fulfilling all the eligibility conditions for the General (UR) category, will be considered only under General (UR) vacancies. In case, the process of recruitment fall in next financial year, a fresh certificate will have to be produced before appointment / DV.

8. HORIZONTAL RESERVATION:

8.1: This notification also provides horizontal reservation for Ex-Servicemen (Ex. SM) and PwBD, irrespective of their social community;

8.2: The vacancies shown in the Vacancy Table also include those reserved for Ex.SM and PwBD;

8.3: Ex.SM candidates can also apply against unreserved vacancies of any post(s) not exclusively earmarked for them. They will be eligible for age relaxation and fee exemption while applying for these posts.

8.4: Similarly, PwBD candidates can also apply against unreserved vacancies of any post(s) not exclusively earmarked for them, but the post must be indicated as suitable for their disability. They will be eligible for age relaxation and fee exemption while applying for these posts.

8.5: If vacancies reserved for PwBD cannot be filled due to the non-availability of suitable candidates under that category of disability or for any other reason, they will not be filled and will be carried forward as backlog vacancies.

9. EX-SERVICEMEN:

9.1: The term 'Ex-Serviceman' means a person who has served in any rank (whether as a combatant or a non-combatant) in the regular Army, Navy, or Air Force of the Indian Union but does not include a person who has served in the Defence Security Corps., the General Reserve Engineering Force, the Lok Sahayak Sena, and the Para Military Forces, and -

- a) who either has been retired or relieved or discharged from such service, whether at his own request or being relieved by the employer after earning his or her pension; (or)
- b) who has been relieved from such service on medical grounds attributable to military service or circumstances beyond his control and awarded medical or other disability pension; (or)
- c) who has been released from such service as a result of a reduction in establishment; (or)
- d) who has been released from such service after completing the specific period of engagement, otherwise than on his own request, or by way of dismissal, or discharge on account of misconduct or inefficiency and has been given a gratuity; and includes personnel of the Territorial Army, namely, pension holders for continuous embodied service or broken spells of qualifying service; (or)
- e) Personnel of the Army Postal Service who are part of the Regular Army and retired from the Army Postal Service without reversion to their parent service with pension, or are released from the Army Postal Service on medical grounds attributable to or aggravated by military service or circumstances beyond their control and awarded medical or other disability pension; (or)
- f) Personnel who were on deputation in the Army Postal Service for more than six months prior to 14th April 1987; (or)
- g) Gallantry award winners of the Armed forces, including personnel of the Territorial Army; (or)
- h) Ex-recruits boarded out or relieved on medical grounds and granted medical disability pension w.e.f. 01.02.2006.

9.2: Persons serving in the Armed Forces of the Union, who on retirement from service would come under the category of Ex-Servicemen, are eligible to apply for re-employment one year before the completion of the specific terms of engagement and avail themselves of all concessions available to Ex-Servicemen but such persons shall not be permitted to leave the uniform until they complete the specific terms of engagement in the Armed Forces of the Union.

9.3: Accordingly, such serving Defence personnel to be released within one year (i.e., on or before 31/07/2027) from the closing date of submission of applications against this notification can also apply, both for vacancies earmarked for Ex-Servicemen and for posts not reserved for them. However, they should possess the prescribed Educational Qualification as of the closing date of submitting applications for this notification.

9.4: Ex-Servicemen candidates who have already secured civil employment under the Central Government in Group 'C' & erstwhile Group 'D' (including PSUs, Autonomous Bodies/Statutory Bodies, Nationalized Banks, etc.) after availing of the benefits given to Ex-Servicemen will be permitted only the benefit of age relaxation as prescribed for Ex-Servicemen for securing another civil employment in a higher grade or cadre in Group 'C'/ erstwhile Group 'D' under Central Government. Such candidates will not be considered for the vacancies reserved for ex-servicemen in central government jobs.

9.5: If an Ex-Serviceman applies for various vacancies before joining any Civil employment, they can avail themselves the benefit of reservation as Ex-Serviceman for any subsequent employment, subject to the condition that an Ex-Serviceman as soon as he joins any Civil employment, should give self-declaration/undertaking to the concerned employer about the details of application against this notification. The

acknowledged copy of this declaration and NOC from the civil employer should be produced during DV, failing which their candidature shall be cancelled. Further, this benefit would be available only regarding vacancies filled on direct recruitment and wherever reservation is applicable to the Ex-Servicemen.

10. PERSONS WITH BENCHMARK DISABILITIES (PwBDs):

Categories of disabilities (subject to a minimum of 40% disability) for this recruitment are given below:

VI: Visually Impaired, (B=Blind & LV=Low Vision)

HI - Hearing Impairment (Deaf, Hard of Hearing)

LD - Locomotor Disability (OA=One Arm, OL=One Leg, OAL=One Arm-Leg, DW=Dwarfism)

NOTE: The candidates may please refer to the GOI website <https://depwd.gov.in/acts/> and check the relevant portions of the Rights of Persons with Disabilities Act, 2016, for further details.

10.1: The suitability or otherwise of a post for PwBD has been indicated in the Post Parameters Table (Annexure-A) against each post under the column "Suitability for Persons with Benchmark Disabilities" with details of a specified sub-category of disability.

10.2: PwBD candidates must be careful to apply only for posts clearly mentioned as suitable for their benchmark disability or specified sub-category of disability to avoid disqualification.

10.3: DEGREE OF DISABILITY FOR RELAXATION AND COMPETENT AUTHORITY FOR ISSUE OF DISABILITY CERTIFICATE: Only such persons would be eligible for a relaxation of conditions/reservation in a respective community in services/posts who suffer from not less than 40 percent of relevant disability. A person who wants to avail the benefit of relaxation will have to submit a Disability Certificate issued by a Competent Authority, as per proforma at **Annexure-V(A), V(B) & V(C) {Form V, VI or VII as applicable as prescribed in Rule 18(1) of the Gazette Notification (Extraordinary) dated 15th June 2017 of the Rights of Persons with Disabilities Rules, 2017}** at the time of DV.

10.4: Assistance of Scribe: The candidates affected by Cerebral Palsy/candidate in category of Blindness, can avail the assistance of a SCRIBE for writing answers on their behalf. In case of other category of persons with benchmark disabilities, the provision of scribe can be allowed on production of a certificate to the effect that the person concerned has physical limitation to write and scribe is essential to write examination on his behalf, from the Chief Medical Officer/Civil Surgeon/Medical Superintendent of a Government Health Care institution. The candidate can avail the assistance of scribe after producing the certificate as per Annexure V(G) and submission of letter of undertaking as per Annexure V(D) at the examination centre. The candidates must indicate this in their ONLINE application to engage a scribe. The engagement of a scribe will be subject to the following conditions:

10.4.1: A PwBD candidate eligible for a scribe must arrange the scribe on their own. KRCL shall not provide a scribe.

10.4.2: A separate e-call letter will be issued to the scribe accompanying the candidate.

10.4.3: The candidate shall be responsible for any misconduct of the scribe during the examination.

10.4.4: The scribe should not be a candidate in this notification.

10.4.5: The same scribe should not be engaged by more than one candidate. Both - the scribe and the candidate - shall give a declaration to this effect. Any violation, if detected at any stage, will result in disqualification of both the candidate and the scribe.

10.4.6: The candidates requesting a scribe must provide additional details of their Scribe [as per Annexure-V(D)] in the ONLINE application so that KRCL can issue necessary e-call letters.

10.4.7: During the CBT, the e-call letters shall be signed by both the candidate and the scribe. A change of scribe is not permissible at the CBT venue, and hence, it is the candidate's responsibility to ensure the availability of the same scribe. However, under exceptional circumstances, a change may be allowed, duly recording reasons and filling out the relevant details, including a photograph of the changed scribe.

10.4.8: The candidates availing the assistance of a scribe shall be eligible for compensatory time of 20 minutes for every hour of CBT.

10.4.9: All one-eyed candidates and candidates whose visual degree of disability is less than 40% shall not be eligible for engaging a scribe.

10.5: Selected PwBD candidates will be subjected to a medical examination by Konkarn Railway Medical Authorities after their DV. Only those conforming to the prescribed Medical Standards will be eligible for empanelment (against posts identified as suitable for their disability).

11. EDUCATIONAL QUALIFICATION:

- (a) Please see the Post Parameters Table (Annexure-A) for the prescribed qualifications for each post.
- (b) The candidates appearing and awaiting final examination results of the prescribed educational/technical qualification can also apply. However, they will be required to produce the requisite certificate of having acquired the educational qualification at the time of document verification, failing which their candidature will be rejected. No extra time will be permitted after due document verification date.
- (c) Diploma/Degree in Engineering will not be accepted unless otherwise specified, instead of Course Completed Act Apprentices/ITI for the Technicians in Pay Level-2 post. Graduate Act apprentice will not be accepted in place of Course Completed Act Apprenticeship (CCAA).

12. HOW TO APPLY:

Preference of Post:

Multiple posts in various PML, their details, and other requirements have been indicated in para (2) & (3) of this notification. The candidates can apply for multiple posts based on their educational qualifications. The candidates are required to indicate their post-wise preference very carefully. Once exercised in the ONLINE application, options shall be final, and no request for change shall be entertained. Therefore, the candidates are advised to exercise the option for post(s) carefully.

KRCL will allot only one post to the selected candidate as per the preference of the candidate, subject to merit, vacancy position, and qualifying the various stages of the selection process.

Note: Any request by the candidates selected for a specific post as per their preference for allotment of a post lower in the preference shall not be entertained.

- b) The candidates should ensure they possess/fulfil all eligibility conditions prescribed for the post as of the closing date for applying.
- c) The candidates who possess/fulfil all eligibility conditions prescribed for the post as of the closing date for applying may apply for one or more posts in a single application in the order of their preference for which the candidate is eligible and interested in applying. Payment of the prescribed examination fee for each CBT Examination Group selected by the candidates as indicated under Para (3) of this notification is to be made by the candidates at the time of filling out an ONLINE application. Any attempt by a candidate to register more than once against this notification shall result in the rejection of all registrations, disqualification, and debarment from the selection process of this notification.

The candidates are advised to refer to paras. 18 and 19 of this notification for details regarding the examination fee and mode of payment.

- d) Eligibility of the candidates to be called for CBT will be considered only on the strength of the information furnished in the ONLINE Application. If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in his/her application is false/incorrect, or the candidate has suppressed any relevant information, or the candidate does not satisfy the eligibility criteria for the post, his/her candidature will be rejected immediately.**

Furnishing of information of the Scribe is mandatory. Change of the Scribe at the examination venue is generally not permitted. However, under exceptional circumstances, the change may be allowed by duly recording reasons and filling in the relevant details, including a photograph of the Scribe.
- j) The candidates are further advised to visit KRCL's website frequently to get the latest information on the various stages of the recruitment process or any changes to this notification.
- k) The candidates are responsible for proving with valid documents that all the information they submitted in the ONLINE application is true.
- l) **Registration Process & Filling of Online Application:** The candidates shall first register their names by visiting the official website of KRCL, www.konkanrailway.com. 13. INVALID APPLICATIONS / REJECTIONS:

Online applications are liable for rejection on the following grounds, amongst others:

- Invalid photos on account of Black and White photos, photos with a cap or wearing goggles/dark glasses, disfigured photos, small photos, full-body photos, photos having only one side view of the face, unrecognizable photos, photostat copies of the photos, group photos, online applications without photos, candidate's signatures in capital letters, among others;
- Any other irregularities which are observed and considered invalid by KRCL.
- In case the application is rejected, the candidates will be able to view their status ONLINE on the KRCL website along with the reason(s) for rejection(s), which is final and binding; no further correspondence shall be entertained on the subject. No refund of the examination fee will be made on account of the rejection of the application. SMS and e-mail alerts shall also be sent to the candidates using their registered mobile numbers and e-mail IDs, as indicated in their ONLINE application. The candidates will not be intimidated by post.

14. RECRUITMENT PROCESS:

14.1: The recruitment process of Section Controller (SCOR), Station Master (SM) and Assistant Loco Pilot (ALP) shall involve Computer Based Test (CBT), Computer-Based Aptitude Test/OMR-based Aptitude Test, Document Verification, and Medical Examination. The candidates qualifying for the CBT shall be called for a Computer-Based Aptitude Test/OMR-based Aptitude Test eight times of the number of posts notified in the SCOR/SM/ALP category. However, this number may vary depending on the total number of vacancies. A merit list of candidates qualifying for the Computer-Based Aptitude Test/OMR-based Aptitude Test will be prepared by giving 70% weightage to CBT marks and 30% weightage to Aptitude test marks. Based on the merit list, candidates will be called for DV and then Medical.

14.2: The recruitment process for the posts of Senior Section Engineer (Mechanical), Senior Section Engineer (S&T), Junior Engineer (Civil), Junior Engineer (Mechanical), Goods Train Manager (GTM), Commercial Supervisor, Technician-III/Mechanical and ESTM/III shall involve CBT followed by the Document Verification and Medical Examination.

14.3: The recruitment process for the Track Maintainer posts shall involve CBT followed by Document Verification, Physical Efficiency Test (PET), and Medical Examination.

The candidates qualifying the CBT will be called for document verification (DV) five times of the number of vacancies notified. After that, the candidates about three times the number of vacancies notified, who qualify in CBT and DV, will be called for PET. PET is mandatory and the same will be qualifying in nature.

The date, time, and venue for CBT and other additional activities as applicable shall be decided by KRCL and intimated to the eligible candidates. Request for any modification in this regard shall not be entertained.

14.4: CBT: The CBTs are tentatively scheduled in the **September, 2026**.

The CBT is of screening in nature, and the standard of questions will generally be in conformity with the educational standards and/or minimum technical qualification prescribed for the post. The final merit shall be prepared based on the CBT score.

Wherever Computer-Based Aptitude Test/OMR-based Aptitude Test is mandatory, merit will be prepared by giving 70% weightage to CBT marks and 30% weightage to Aptitude test marks. Based on the merit list, candidates will be called for DV and then Medical.

Negative Marking: Incorrect answers in CBT will be marked negatively. One- mark will be deducted for each wrong answer from allotted marks.

14.5: Banned Items: The candidates carrying banned items like communication devices and Electronic gadgets (Mobile phones, Bluetooth devices, pen drives, laptops, calculators, smart watches), bangles, chains, bracelets, hearing aids, wallets/purses, metallic wears, etc., or any stationery items like pen/pencil shall not be allowed to appear

during the examination. Any infringement/violation of this instruction shall lead to disqualification, legal action, and debarment from future examinations of KRCL.

Cloakroom arrangements for safekeeping belongings may not be available at the examination venues. Therefore, the candidates are advised to refrain from bringing any valuables or banned items, including mobile phones, etc., to the examination venue. KRCL management shall not be responsible for the loss of any such item brought to the CBT venue.

1. **Engineering Mechanics:** Resolution of forces, Equilibrium and Equilibrant, parallelogram law of forces, triangle law of forces, polygon law of forces and Lami's theorem, couple and moment of a couple, condition for equilibrium of rigid body subjected to number of coplanar non-concurrent forces, definition of static friction, dynamic friction, derivation of limiting angle of friction and angle of repose, resolution of forces considering friction when a body moves on horizontal plane and inclined plane, calculation of moment of inertia and radius of gyration of : **(a)** I-Section **(b)** channel section **(c)** T-Section **(d)** L-Section (Equal & unequal lengths) **(e)** Z-Section **(f)** Built up sections (simple cases only), Newton's laws of motion (without derivation), motion of projectile, D'Alembert's principle, definition law of conservation of energy, law of conservation of momentum.
2. **Material Science:** Mechanical properties of engineering materials – tensile strength, compressive strength, ductility, malleability, hardness, toughness, brittleness, impact strength, fatigue, creep resistance. Classification of steels, mild steel and alloy steels. Importance of heat treatment. Heat treatment processes – annealing, normalizing, hardening, tempering, carburizing, nitriding and cyaniding.
3. **Strength of Materials:** Stress, strain, stress strain diagram, factor of safety, thermal stresses, strain energy, proof resilience and modules of resilience. Shear force and bending moment diagram – cant lever beam, simply supported beam, continuous beam, fixed beam. Torsion in shafts and springs, thin cylinder shells.
4. **Machining:** Working principle of lathe. Types of lathes – Engine lathe – construction details and specifications. Nomenclature of single point cutting tool, geometry, tool signature, functions of tool angles. General and special operations – (Turning, facing, taper turning thread cutting, knurling, forming, drilling, boring, reaming, key way cutting), cutting fluids, coolants and lubricants. Introduction to shaper, slotter, planer, broaching, milling and manufacture of gears, heat treatment process applied to gears.
5. **Welding** – Introduction, classification of welding processes, advantages and limitations of welding, principles of arc welding, arc welding equipment, choice of electrodes for different metals, principle of gas (oxy-acetylene) welding, equipment of gas welding, welding procedures (arc & gas), soldering and brazing techniques, types and applications of solders and fluxes, various flame cutting processes, advantages and limitations of flame cutting, defects in welding, testing and inspection modern welding methods, (submerged, CO₂, atomic – hydrogen, ultrasonic welding), brief description of MIG & TIG welding.
6. **Grinding & Finishing Process:** Principles of metal removal by grinding, abrasives, natural and artificial, bonds and binding processes, vitrified, silicate, shellac rubber, grinding machines, classification: cylindrical, surface, tool & cutter grinding machine, construction details, relative merits, principles of centreless grinding, advantages & limitations of centreless grinding work, holding devices, wheel maintenance, balancing of wheels, coolants used, finishing by grinding, honing, lapping, super finishing, electroplating, basic principles – plating metals, applications, hot dipping, galvanizing tin coating, parkerising, anodizing, metal spraying, wire process, powder process and applications, organic coatings, oil base paint, lacquer base enamels, bituminous paints, rubber base coating.

7. Metrology: Linear measurement – Slip gauges and dial indicators, angle measurements, bevel protractor, sine bar, angle slip gauges, comparators (a) mechanical (b) electrical (c) optical (d) pneumatic. Measurement of surface roughness; methods of measurements by comparison, tracer instruments and by interferometry, collimators, measuring microscope, interferometer, inspection of machine parts using the concepts of shadow projection and profile projection.

8. Fluid Mechanics & Hydraulic Machinery: Properties of fluid, density, specific weight, specific gravity, viscosity, surface tension, compressibility capillarity, Pascal's law, measurement of pressures, concept of buoyancy.

Concept of Reynold's number, pressure, potential and kinetic energy of liquids, total energy, laws of conservation, mass, energy and momentum, velocity of liquids and discharge, Bernoulli's equation and assumptions, venturi meters, pitot-tube, current meters. 14.15: OBJECTION AGAINST ANSWER KEY:

After the CBT, a link shall be provided on the Konkan Railway website (www.konkanrailway.com) to enable the candidates who appeared in the CBT to view their question papers, responses, and answer keys. After viewing these details, objections, if any, regarding the questions, options, and keys published can be raised by the candidates, for which a schedule will be published on the KRCL website. The candidates can submit their objections online by paying fees of Rs. 59/- (Applicable fee of Rs. 50/- + GST @ 18%) + payment of gateway charges, if any, for each objection. If the objection is correct, the fee paid against such valid objections shall be refunded to the candidate, duly deducting bank charges as applicable. However, if the objection is incorrect, the candidate will forfeit the payment.

15. NORMALISATION OF MARKS:

The examination may have to be conducted in multiple sessions in CBT and for CBAT / OMR Based Aptitude Tests. Accordingly, normalisation of marks will be done for CBTs and for CBAT / OMR Based Aptitude Tests held in multiple shifts. Short listing of the candidates for various stages shall be based on the normalized marks obtained by them whenever CBT/ CBAT / OMR Based Aptitude Tests is conducted in multiple sessions for the same syllabus.

16. PHYSICAL EFFICIENCY TEST:

- 1) It is the candidates' responsibility to ensure that they are medically fit enough to attempt the PET. KRCL will not be responsible for any injury/harm suffered by candidates as a result of participating in the PET.
- 2) The Physical Efficiency Test (PET) consists of two stages. To ensure uniformity, the candidates will be tested for Carrying of Weight to specified distance in specified time first and if successful in this test, then they will have to undergo Running Test after a recovery gap. Failing in the first Test, i.e. Weight carrying will result in elimination at that stage itself. The Weight carrying test will involve lifting a sand bag (without any handle) from a bench/platform at around waist height and carrying it in whichever manner candidate wants to carry above the ground till the destination point without dropping the sandbag on ground.

17. MEDICAL STANDARDS FOR THE POSTS:

The Candidates who have undergone Lasik surgery or any other surgical procedure to correct refractory error are not eligible for the post having Medical Standard of A-1, A-2, A-3, and B-1.

The Candidates suffering from vertigo are not Fit in A1, A2, A3.

The Candidates with contagious and infective disorders, epilepsy, asthma, otorrhea, psychiatric illness, ischemic heart disease, stammering, valvular disease, impaired hearing, hypertension, obesity, poor renal status, etc. will not be eligible for A1, A2, A3, and B1.

Contact lens are not allowed for any of the posts notified.  - Sitting Member of Parliament of Rajya Sabha for persons of the district in which these MPs normally reside;
 - Union Minister for any persons from anywhere in the country.(OR)
 - b) BPL Card or any other certificate issued by the Central Government under a recognized poverty alleviation programme
- (OR)

All EBC candidates who seek concessional fees should fill in the relevant details of a valid EBC certificate/BPL card in the ONLINE application. The same must also be submitted in the original at the time of DV, failing which, their candidature will be rejected.

NOTE: EBC and EWS are distinct categories. EBC candidates are entitled only for fee concession and not entitled for job reservation.

19. MODES OF PAYMENT OF FEE

- ONLINE fee payment will only be accepted through Internet banking, debit/credit cards, or UPI. The candidate shall bear all applicable service charges.
- The candidates can pay the fee ONLINE only. There will be no option to pay the fee through any other mode.

- e) **Free Travel Facility:** In the case of SC/ST candidates who have uploaded the details of their community certificate to avail the benefit of free travel authority (Sleeper Class Railway Pass), the e-call letter for CBT/CBAT or OMR Based Aptitude Test/ DV/ME (as applicable) will contain the free travel authority and such candidates will be allowed to book a ticket on submission of self-attested photocopy of the e-call letter and SC/ST certificate at the ticket booking counter. During the journey, these candidates should carry an original community certificate and one original prescribed proof of identity for undertaking the journey, failing which they will be treated as traveling without a ticket and charged accordingly.
